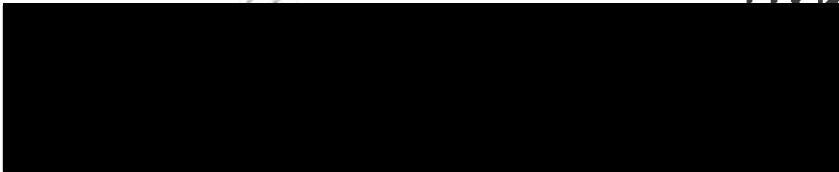

Page 182. This is likely the hardest chapter I'll ever write. And frankly, I'm not even sure if it fits with the themes of Blackness or queerness or critical race theory in this book—nor do I really care.

Page 203. There you stood in front of me fully erect and said, "TASTE IT." At first, I laughed and refused. But then you said, "COME ON, MATT, TASTE IT." This is what other boys like us do when we like each other." I finally listened to you.

The whole time I KNEW IT WAS WRONG, not because I was having sexual intercourse with a guy, but that you were my family..... That's when YOU BEGAN ORAL SEX on me as well.
